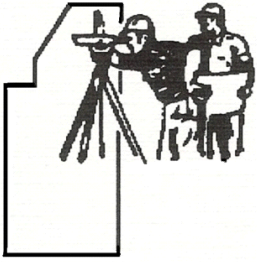

General Provisions

This form is part of your permit: The provisions, requirements and restrictions stated herein shall govern the movement of vehicles and/or objects authorized by a written permit issued by the Piatt County Highway Department. Failure to comply with any of these provisions may result in the Piatt County Highway Department denying any further movement permits on Piatt County rights-of-way until such time as proper compliance can be provided.

Permit to accompany movement: The driver of the vehicle shall have the permit as well as these provisions, in written or electronic form, in their possession during the movement and shall show said permit, on demand, to any law enforcement officer and/or any Piatt County Highway Department employee. The permit covers only the person or firm designated as petitioner and is not transferable.

Agreement: The acceptance of the permit by the petitioner constitutes an agreement that the movement will be made strictly in compliance with the terms set forth in the permit and the applicable provisions of the Piatt County Highway Department's Policy, as well as the Illinois Department of Transportation's policies contained in its publications "OVERSIZE AND OVERWEIGHT PERMIT MOVEMENTS ON STATE HIGHWAYS (current edition)" and "THE ILLINOIS VEHICLE CODES (current edition)."

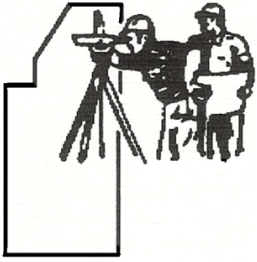
Jurisdiction: This permit is effective only insofar as the Piatt County Highway Department has jurisdiction and does not release the petitioner from complying with any other existing federal, state, county, or local laws, statutes or codes that may apply to the permitted movement.

Permitted Route: The permitted route is valid only with respect to Piatt County Highways and Structures as listed on the permit. The permit is not valid on any highway or structure A) posted for a load limit less than the gross weight of the move and/or B) on any highway closed to traffic and/or C) on any highway not under the jurisdiction of the Piatt County Highway Department. The right to use highways other than those specified is neither implied nor granted. The petitioner must obtain permission from the proper authority to use state or local streets, highways, roads, or rights-of-ways.

Authorized Times of Movements: All movements are authorized from one half hour before sunrise to one half hour after sunset Monday through Friday, and from one half hour before sunrise until noon, Saturday. Movements are further restricted on specified holidays, beginning at noon on the day preceding the holiday or the holiday weekend. The specified holidays are: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, and Christmas Day.

Highway Conditions and Inclement Weather: Moves shall not be made when highway is covered with snow or ice, or when visibility is unduly impaired by rain, snow, fog, smog, or at any time travel conditions are considered to be unsafe by the Illinois State Police, the Piatt County Sheriff, or the Piatt County Highway Department. The police, the Piatt County Sheriff, or Piatt County Highway Department employees, may direct or escort a vehicle off the roadway to a safe place until such time as conditions allow safe movement.

Speed: Maximum speed shall be 5 M.P.H. below the posted speed limit.

Structure Analysis: Any load in excess of 80,000 pounds crossing a county structure shall be required to have a structural analysis performed by a licensed Illinois Structural Engineer. The cost of structural analysis for each structure crossed shall be paid for by the petitioner and shall be in addition to the cost of the permit.
